ORDER

The Pole rental rates for drawal of cables over KSEBL poles from 01.04.2011 were fixed for a period upto 31.03.2021 as per order read as 2nd above. Considering the representation submitted by the Cable TV Operators Association to the Hon'ble Chief Minister of Kerala, requesting revision of pole rental rates, a three member committee was constituted for studying the matter and after detailed examination of the report submitted by the Committee, the Government as per orders read as 6th and 7th above, have issued revised rates for pole rent for Cable TV Operators with effect from 01.04.2021.

Based on the decision taken in the meeting of Full Time Directors held on 18.03.2021, directions were issued by the Director (Distribution, IT & HRM) to the field offices, as per letter read as 9th above, to collect pole rental charges as per the Government orders and to ascertain that fresh agreements are executed only after clearing the arrears.

As per order read as 5th above, KSEBL has given orders to levy simple interest rate @12% per annum for recovery of all dues, other than current charge receivable unless there is a separate rate as per the agreement executed with the party at default and that the new rate @12% shall be applicable in all cases pending settlement.

Based on the requests received from the field seeking clarification in the rate of interest applicable for delayed payments of pole rent and the interest rate applicable in clearing arrears through installment facility, the matter was placed before the Full Time Directors for a decision and also for ratification in the action of the Director (Distribution, IT & HRM) in issuing sanction for executing new agreements with the Cable TV Operators/other service providers with effect from 01.04.2021.

Having examined the matter in detail, the Full Time Directors in the meeting held on 08.04.2021 resolved to ratify the action of the Director (Distribution, IT & HRM) in issuing sanction for executing new agreements with Cable TV Operators/other service providers with effect from 01.04.2021, as per decision in the meeting of Full Time Directors held on 18.03.2021.

Further resolved to apply the rate of 12% for Cable TV Operators/others for delayed payments of pole rent while executing fresh agreements with effect from 01.04.2021.

Further resolved to authorise the Deputy Chief Engineers of Electrical Circles to clear the pole rental arrears by giving a maximum of 10 installments considering the period and amount of arrear, @12% interest unless there is separate rate as per agreement.

Orders are issued accordingly.


